1. With reference to the D.O. Letter 1st cited it is to inform that Sri. Erukula Mallesh, Ex-servicemen has submitted a representation addressed to the National Commission for S.T., New Delhi against Tahasildar, Shamirpet (M) and his subordinates and certain Police personnel of Alwal P.S. limits of Cyberabad Commissionerate.

2. Facts of the case are that, Sri. Erukula Mallesh falsely claimed that he was allotted 5 acres of land in the Sy. No. 336 of Jawahar Nagar (V) Shamirpet (M) under Ex-Servicemen quota by jawahar Nagar Co-Operative Land Colonization Society among with other Ex-servicemen. It is Government land admeasuring 5977 acres at Jawahar Nagar. In the year 1952 the Government issued Go.Ms No. 25 Revenue Department dated: 23.10.1952 assigning a part of land to the Ex-servicemen. The Society which was allotted the land, in turn allotted it on lease basis to 149 individuals Ex-servicemen. As affairs of the society were mis managed and Funds misused, the District Collector later suspend the Society. Sri. Kulthadi Mallesh @ E.Mallesh name neither in the

Subsequently, after completion of investigation the Inspector, Alwal P.S. charged sheeted the case on 15.07.09 in the Court of XV Metropolitan Magistrate, Cyberabad at Medchal and it is P.T. vide CC No. 9/09.

6. Further, the allegation leveled by the petitioner against the Tahasildar, Shamirpet (M) and his subordinates and certain Police personnel of Alwal P.S. are false and base less and no further action need to be taken into the petition of Sri. Erukula. Mallesh, Ex-Servicemen.
