With reference to above subject cited above I am to submit that on 17.08.05 at 18.00 hours the complainant Sri D.Balaji s/o Chandrudu age: 30 years Caste: S.T., Lambada, Occ: Sr. Engineer, BHEL, r/o Q.No.2070/D BHEL Township R.C.Puram came to P.S. R.C.Puram and lodged a complaint stating that on 16-08-2005 evening at 17.00 hours he was not present in house his son Chandrakanth aged about 4 years while playing on his cycle fell down, on seeing this Mr.Digambar Reddy staff No.1816616 who is residing in the ground floor of Q.No.2070/B started abusing his son in filthy language stating that "LAMBADI NA KODUKA EKKADANUNDI VACHAVURA NEEVU LANJA KODUKA NA INTI MUNDU CYCLE THOKKUTHAVA" and he also tried to beat his son Chandrakanth. On seeing this from their balcony his wife asked Digambar Reddy as to why he is abusing his son, then he also abused her saying that "NUVVU EVARE LAMBADI MUNDA NANNU ADAGATANIKI ENTHA DAIRYAM". The complainant's wife informed him about the incident. At about 18.30 hours he asked Digambar Reddy as to why he has abused his wife and son, then he started abusing him saying "LAMBADI NA KODUKA NANNU ADAGATANIKI ENTHA DAIRYAMRA" and he came on to him stating that his relative is a DSP and he is Union leader no body can do him any thing. Again on 17-08-2005 since morning Aravind Kumar son of Digambar Reddy and his associates were moving in front of his house and abused him stating that "LAMBADI NA KODUKA MAA MEEDA POLICE CASE PETTADANIKI NEEKU ENTA DAIRYAM" and also threatned him with dire consequences. Earlier also Digambar Reddy took Minor girls from Lambada Thandas and employed them in his house for work and harassed them. He is also bringing Minor girls from Thandas of Warangal district and supplying to others for domestic help. Finally he requested to take legal action against Digambar Reddy and his son for abusing him in filthy language by taking his caste name.

On receipt of the above complaint the SI R.C.Puram PS has registered a case in Cr No.284/2005 U/s 3 (i) (x) SC/STs (POA) Act, 1989 and issued FIRs to all the concerned.

Later the investigation took up by the S.D.P.O. R.C. Puram in this case, he visited scene of offence on 17-08-2005, examined the complainant Sri D.Balaji s/o Chandrudu age: 30 years Caste: S.T., Lambada, Occ: Sr.Engineer, BHEL, r/o Q.No.2070/D BHEL Township R.C.Puram and recorded his statement. On 18-08-2005 examined the following witnesses and recorded their statements in detail and also conducted the scene of offence Panchanama drawn the scene of offence rough sketch in presence of Panchas.

- 1) Smt.Dharavath Vijayalaxmi w/o Balaji age: 22 yrs Occ: House wife, caste: S.T. Lambada r/o Q.No.2070/D, BHEL Township, R.C.Puram (Wife of the complainant and victim).
- 2) Sri D.Chandrakanth s/o Balaji, age: 4 ½ years, Student, UKG r/o Q.No.2070/D, BHEL Township R.C.Puram (Son of the complainant and Eye witness).
- 3) Sri Bukya Naik s/o Makya, 20 yrs, Occ: student B.tech IInd year Sadana Engineering College, Mehadipatnam r/o Q.No.2070/D, BHEL Township R.C.Puram (Eye witness to the incident).
- 4) Sri Sanjay Nana Thanke S/o Nanaji Thanke, age: 37 yrs Occ: Manager, BHEL r/o 2070/C, BHEL Township R.C.Puram (Eye witness).
- 5) Smt.G.Renuka W/o Raghuvеer Reddy age: 23 yrs, Occ: House wife r/o Q.No.2070-A BHEL Township R.C.Puram (Eye witness).

The S.D.P.O. R.C. Puram has sent a requisition to MRO Ramachandrapuram to issue caste certificates of the complainant and accused. Accordingly LW-9 enquired and issued a letter vide No.F/3075/2005,dtd: 29-08-2005, 29-10-05 and 08-11-05 stating that the complainant Sri D.Balaji s/o Chandrudu belongs to **S.T. Caste (Lambada)**. The accused A-1 V.Digambar Reddy s/o Narayana Reddy and A-2 V.Aravind Kumar Reddy S/o V.Digambar Reddy are belongs to **Reddy caste O.C.**

Further he also sent a requisition to Estate Officer BHEL Township R.C.Puram to issue residential certificates in respect of accused and the complainant. LW-10 Estate Officer, BHEL Township R.C.Puram has issued Residential certificate vide Lr.No. Ref/HY/TA/EO/2005, dtd.31-08-2005 stating that complainant and accused are staying in BHEL Type-IV quarters i.e the complainant in quarter No.2070-D and the accused A-1 in quarter No.2070-B.


While investigation was under progress, on 10-10-2005 the accused A-1 V.Digambar Reddy s/o Narayana Reddy, working in BHEL Staff No.1816616 and A-2 V.Aravinda Kumar s/o Digambar Reddy both r/o Q.No.2070/B, BHEL, R.C.Puram surrendered before the Honourable court of special judge for trial of offences under section SC/ST POA Act, Medak at Sangareddy vide Dis.No.352/2005 dated: 10-10-2005.

The investigation revealed that, the complainant Sri D.Balaji s/o Chandrudu age: 30 years Occ: Sr. Engineer, BHEL, belongs to S.T community (Lambada) by caste is residing in Q.No.2070/D (1st floor) Type-IV NH-V BHEL Township Ramachandrapuram. The accused Digambar Reddy who is also a Employee in BHEL factory residing in the same building Q.No.2070/B (in ground floor). On 16-08-2005 evening at 17.00 hours the son of complainant Chandrakanth S/o Balaji aged about 4 years was playing with his cycle in front of his house and fell down on the ground, near the Car of accused Digambar Reddy. On seeing this accused Digambar Reddy thinking that the boy fell on his Car he tried to beat him and started abusing him in filthy language stating that "LAMBADI NA KODUKA EKKADANUNDI VACHAVURA NEEVU LANJA KODUKA NA INTI MUNDU CYCLE THOKKUTHAVA". On observing this from Balcony the wife of the complainant questioned the accused Digambar Reddy as to why he is abusing her son, beat the accused also abused her saying that "NUVVU EVARE LAMBADI MUNDA NANNU ADAGATANIKI ENTHA DAIRYAM". On the same

day at about 18.30 hours the complainant returned home after knowing the incident he asked the accused Digambar Reddy as why he abused his wife and son. Upon which both the accused i.e A-1 and A-2 again started abusing the complainant saying "LAMBADI NA KODUKA NANNU ADAGATANIKI ENTHA DAIRYAMRA" and tried to beat him. Thereby the accused A-1) V. Digambar Reddy S/o Narayan Reddy R/o Q.No.2070/B BHEL, Township R.C.Puram A-2) V. Aravinda Kumar s/o Digambar Reddy r/o Q.No.2070/B BHEL, Township R.C.Puram were committed an offence U/s 3 (i) (x) SC/ST (POA), 1989.

In this case the accused were arrested on 10-10-2005 and sent to judicial custody. On 09-11-2005 the case was charged and it is P.T. vide SC.No.44/2005. Case posted to 07.02.2006 for trial.
