MINUTES OF THE SITTING HELD ON 28.12.2015 IN THE REGIONAL OFFICE OF NATIONAL COMMISSION FOR SCHEDULED TRIBES, RANCHI REGARDING DECEIVING OF ASHUR PRIMITIVE TRIBES OF VILL. SAKHUAPANI, KHARAPANI AND GORA PAHAR ETC. BY BAJAJ ALLIANCE AND NON BANKING ORGANISATION.

1. The Superintendent of Police, Gumla stated that the District Police doesn't have expertise to investigate such cases. The CID, being supreme body of investigation of the State, has teams of expert officers who can help investigate the case. Furthermore, the case involves fraudulent misuse of crores of rupees in which hundreds of tribals are affected. It will be advisable that the case is investigated by the CID. Superintendent of Police, Gumla will provide logistic support to it.
2. Smt. Sampat Meena, IG, CID, Jharkhand agreed in the meeting to take over the case and constitute a team of officers to conduct a thorough enquiry/investigation and inform the Commission with the progress in the case/cases.
