**Record of Proceedings of the Sitting taken by Shri. Bheru Lal Meena, Member, NCST on 02/08/2013 at 1130 hrs in the NCST with officers of the Ministry of Railways on the representation of Shri. R.S.Meena, TTE, Jabalpur, Western Central Railways regarding harassment.**

1. The Sitting was chaired by Shri. Bheru Lal Meena, Hon'ble Member, NCST with officers of the Ministry of Railways and Western Central Railways Jabalpur on the rejoinder dated 11/07/2013 of Shri. R.S. Meena, TTE, Jabalpur.
2. The list of officers who attended the Sitting is attached. The petitioner was also present in the Sitting.
3. The petitioner Shri. R.S.Meena submitted that he is working as Pr. TTE at Jabalpur in Western Central Railways (MP). He was witnessed in the incident of misbehavior committed on dated 29/12/2011 with Shri. Pyar Singh Meena another TTE of Jabalpur Division by officers/staff of Vigilance Department because of this, he was being harassed by CTI (D) Jabalpur for which a complaint dated 03/12/2013 was sent in the Commission. Despite of repeated written complaints to local Railway Administration, no action was taken against Shri. SK Khurana CTI (D) who is harassing him continuously. He is being pressurized by Railway Management through CTI (D) to be part of the witness in the case of Shri. Pyar Singh Meena. He is being pressurized to help in departmental inquiry by local Railway Management. Railway Management has also lodged a complaint against him in Civil Police.
4. In compliance of recommendations of NCST mentioned in para 6 of the Record of Proceedings of the Sitting held on 17/04/2013 in the NCST with officers of the Ministry of Railways, Shri. Deepak Kumar Gupta, Senior Divisional Executive Officer, Western Central Railways, Jabalpur vide letter dated 15/07/2013 has intimated that Shri. Roop Singh Meena, TTE Jabalpur has been transferred to the Madan Mahal Railway Station as Announcer in the Coach Guidance System vide order no. 416/2013 dated 29/05/2013. He is working on the above post with effect from 03/06/2013. In this system the position of the compartment of passenger train is feeded in the computer so that it may be displayed in computer on the platform of the Railway station. This work does not belong to the direct public dealing and cash dealing. Thus the recommendations of the NCST have been complied by the Railways.
5. Shri. Roop Singh Meena not being satisfied with the action taken by the Railways authorities had submitted another rejoinder dated 11/07/2013 in the NCST stating that Railway authorities are still harassing him by issuing a charge-sheet dated 25/06/2013 alleging that Shri. Roop Singh Meena, TTE had not checked carefully the passengers travelling at the bearth no. 2 and bearth no. 16 allotted in coach S-5 of the Train running between Katani to Chhabra. Two passengers had travelled in the train without having proper tickets but, Shri. Meena stated that

the charge-sheet issued to him is a part of further harassment and implicating him in new problems.

6. During the discussion, Member NCST advised to the Railway authorities that Shri. Roop Singh Meena, TTE may not be harassed and he should be transferred to any non-cash and non-public dealing department at Jabalpur. In this regard Shri. Rajesh Sharma the Sub Divisional Commercial Manager, Jabalpur has assured to the Hon'ble Member, NCST that there are four posts of TTE lying vacant in the O/o the Chief Commercial Manager, Jabalpur, and Shri. Roop Singh Meena will be considered for posting in the same grade and pay scale against any one of the vacancies. Shri. Roop Singh Meena also accepted the above offer of the posting in the O/o the CCM/JBP.

7. Member NCST advised that action Taken Report will be submitted to the Commission by the Railway authorities before the end of August 2013. Member, NCST has also fixed a Sitting in the Commission on 10/09/2013 at 11:30 hrs for submission of action taken report by the General Manager, Western Central Railways.

8. The Sitting ended with vote of thanks to the Chair.
