**2) Further delegation also submitted copy of following documents;**


i) Memorandum dated 9/6/2014 , submitted by Honorable Chief Minister of Sikkim to the Honourable Prime Minister ,which interalia included issue of inclusion of certain tribe in the list of ST.

ii) D.O letter dated 27/10/2014 from Shri P D Rai, Member of Parliament (Lok Sabha) addressed to Shri Jual Oram, Honorable Minister for Tribal Affairs , regarding inclusion of certain tribes in the list of STs.

3) Chairperson, NCST apprised the delegation that approved modalities for inclusion of tribes in the list of STs, require recommendation of the State Government to GOI ( Ministry of Tribal Affairs) , examination of the proposal by the Registrar General & Census Commissioner of India GI and opinion of NCST . Further, Chairperson, NCST mentioned that prompt action would be taken on the proposals sent to the Commission for its opinion .
