Sub: Review of Constitutional Safeguards for Scheduled Tribes of North Eastern Hill University (NEHU).

महोदय,

The National Commission for Scheduled Tribes (NCST) has been set up under Article 338A of the Constitution of India vested with responsibility, inter-alia to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The NCST is required to present to the Hon'ble President of India, annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

2. Accordingly, the NCST has decided to review the implementation of constitutional safeguards including reservation policy in respect of your University. The NCST has evolved a questionnaire for review, a copy of the same is enclosed for furnishing replies / information by your University. 
3. It is requested that replies / information in respect of questionnaire may be prepared and furnished (six copies) to this Commission **within two week** from receipt of the letter. The replies to various issues covered under the questionnaire will form the basis for review meeting. A soft copy of the replies to the questionnaire may also be sent to js@ncst.nic.in for record. A brief presentation along with measures / programmes taken up by NEHU for welfare of Scheduled Tribes in the country may also be made during the review meeting before the Commission.

4. In this context, it is mentioned that Review Meeting with you and other Senior Officers of NEHU on 25.07.2024 at 04:00 PM at Shillong is to be chaired by Shri N. Chakma, Hon'ble Member, NCST. It is also informed that Hon'ble Member will have a discussion on the grievances and problems of NEHU Students and Employees with office bearers of SC/ST Employees Welfare Association of NEHU before the Review Meeting on 25.07.2024 at 03:00 PM in NEHU at Shillong.

5. It is therefore requested that arrangements for photographs may please be made during the Review Meeting. Appropriate back drop for the Review Meeting may also be arranged/displayed at the venue during the meeting and other places.

It is also requested that the office bearers of SC/ST Employees Welfare Association of NEHU, ST Students of the NEHU and Liaison Officer for STs of NEHU may be asked to attend the meeting on 25.07.2024 at 03:00 PM before Review Meeting.
